\* Countywide - On-Site urine collection is available if the employee cannot be reasonably transported to a collection facility. Compared to the fixed cost of \$35 for testing at a collection facility, on-site collections cost a minimum of \$185. This charge increases if the combined collection and travel time of the technician exceeds 2 hours:

- 6 a.m. to 6 p.m.: \$37.50 per 30 minutes or fraction thereof for time over 2 hours
- 6 p.m. to 6 a.m.: \$56.25 per 30 minutes or fraction thereof for time over 2 hours
