c. **Cesar Mancilla v. County of Los Angeles, et al.**
United States District Court Case No. CV 12-01342

This lawsuit alleges a violation of federal civil rights when Sheriff's Deputies allegedly used excessive force at the Inmate Reception Center.

The Claims Board approved settlement of this matter in the amount of \$99,000.

d. **Angela Lockhart, et al. v. County of Los Angeles**
United States District Court Case No. CV 07-1680 ABC (CW)

This lawsuit concerns allegations that the Sheriff's Department violated the Fair Labor Standards Act.

The Claims Board approved settlement of this matter in the amount of \$60,000.

e. **Claim of Azadeh Mardani**

This claim seeks compensation from the Department of Public Works for real and personal property damages caused from a backflow of sewage due to a sewer main line blockage.
