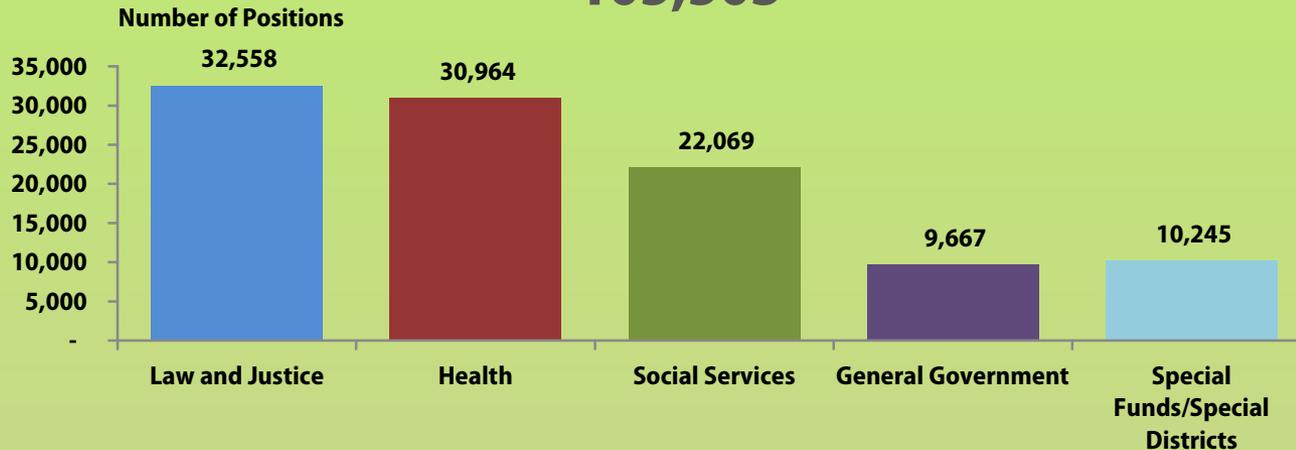

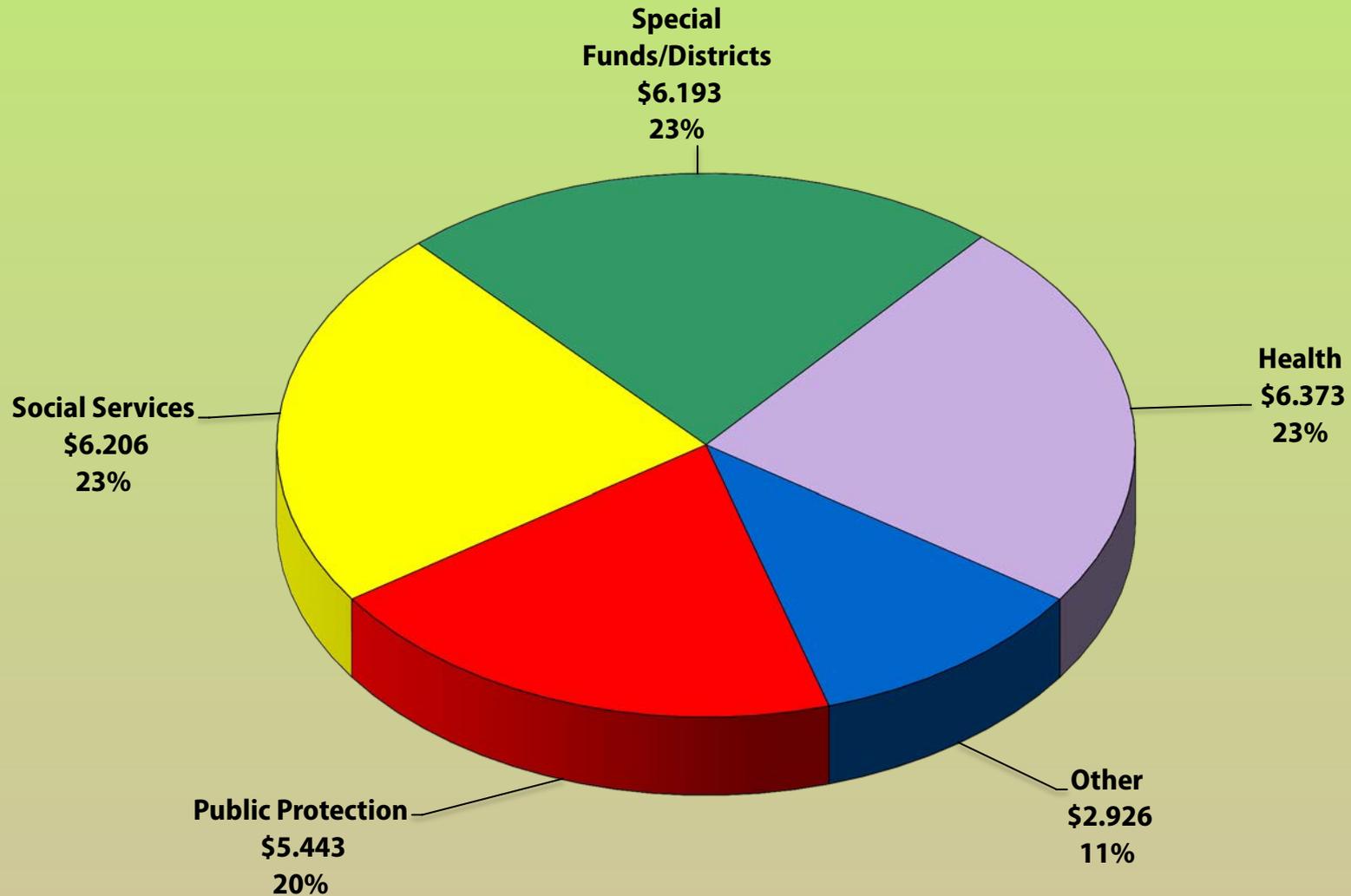

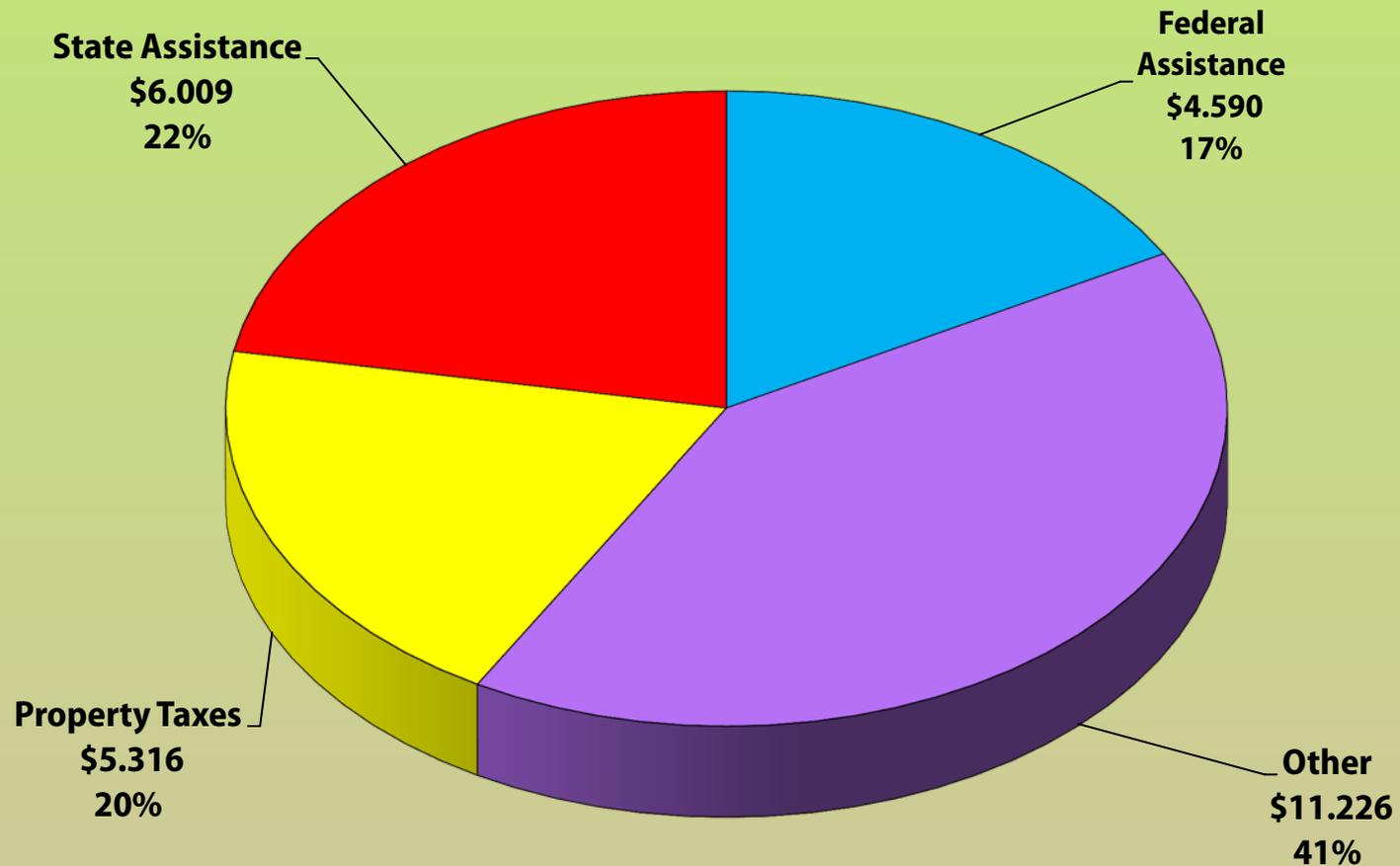

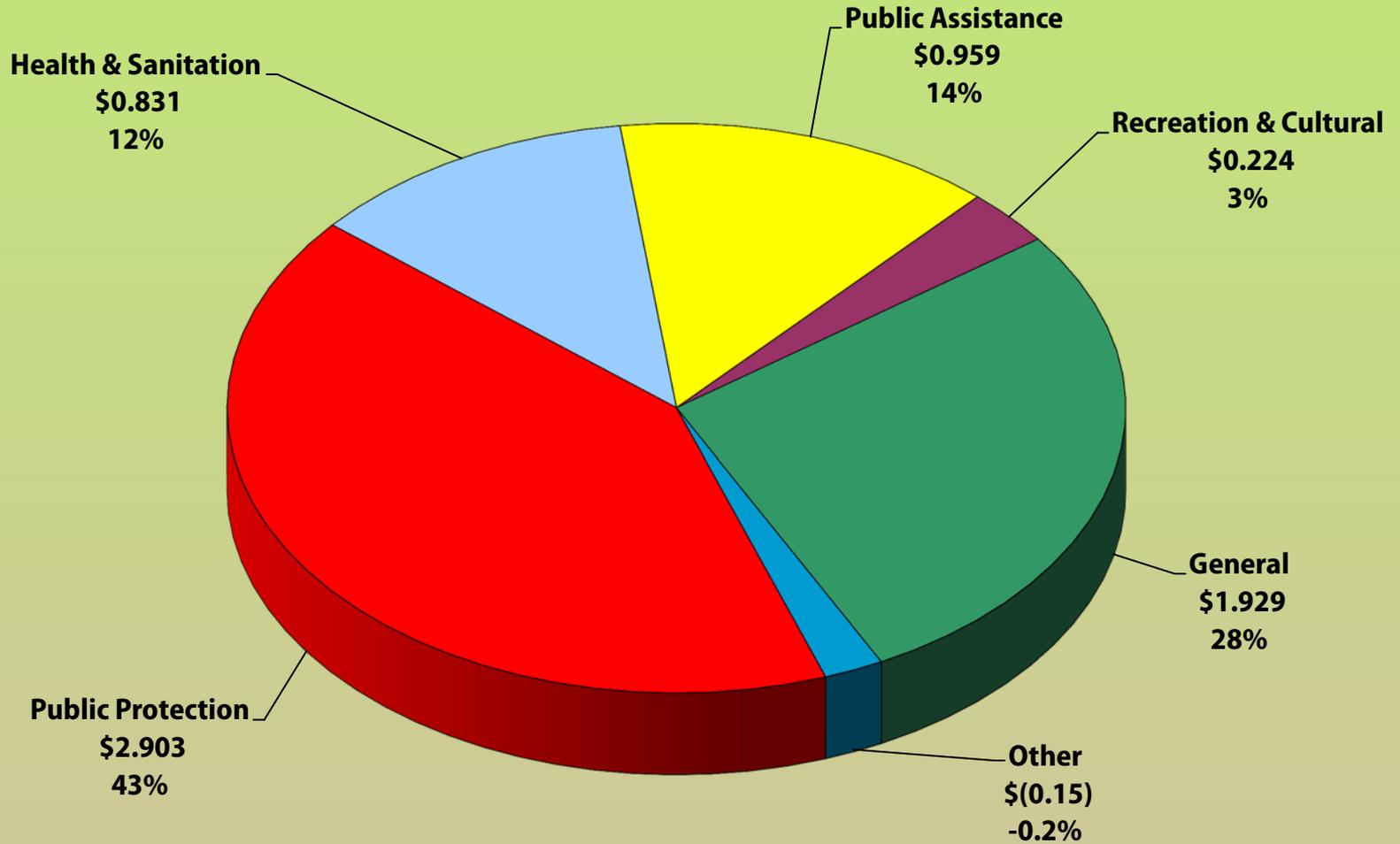
# Total Resources \$27.141 Billion

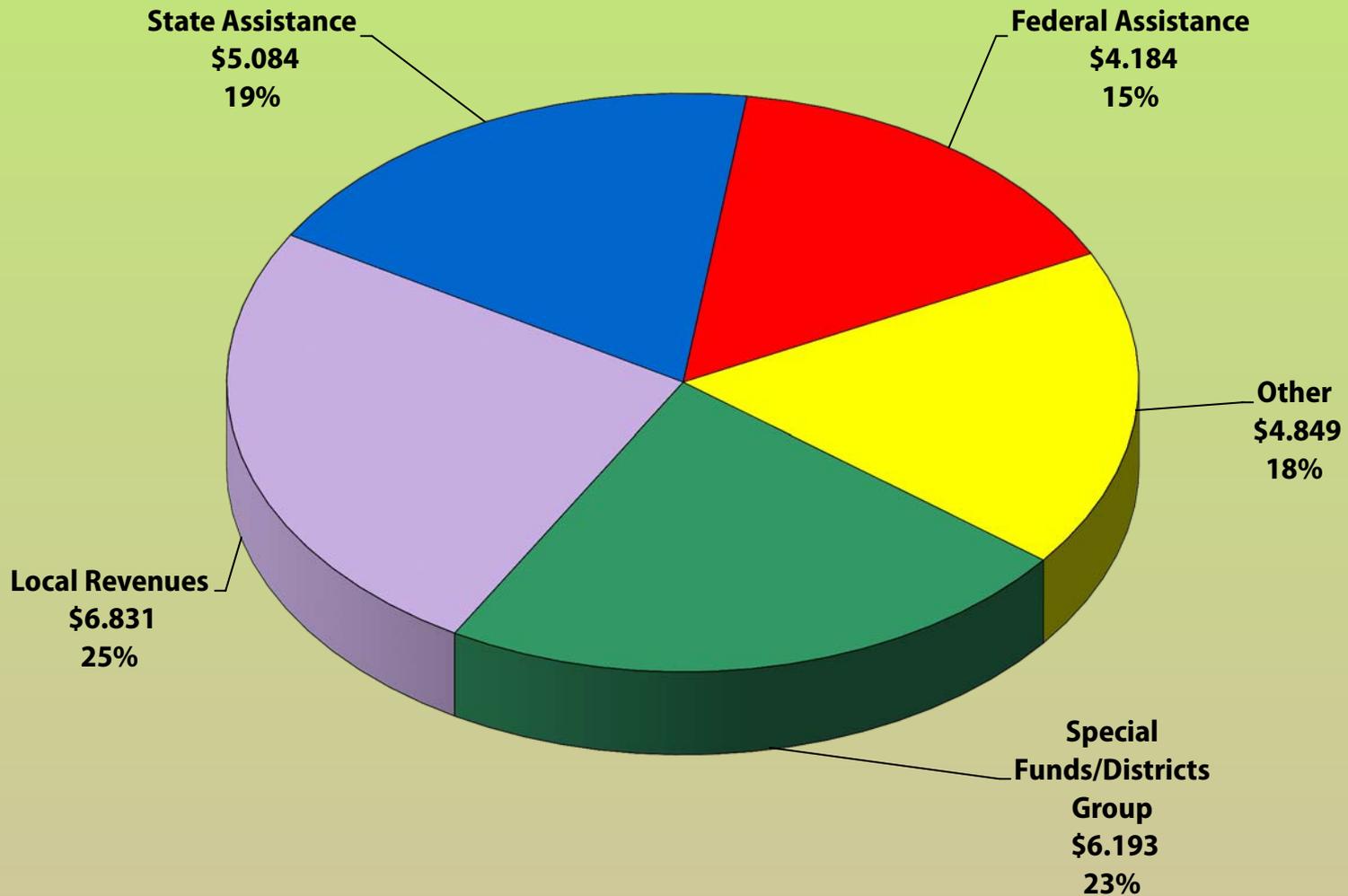
# Net County Cost By Function

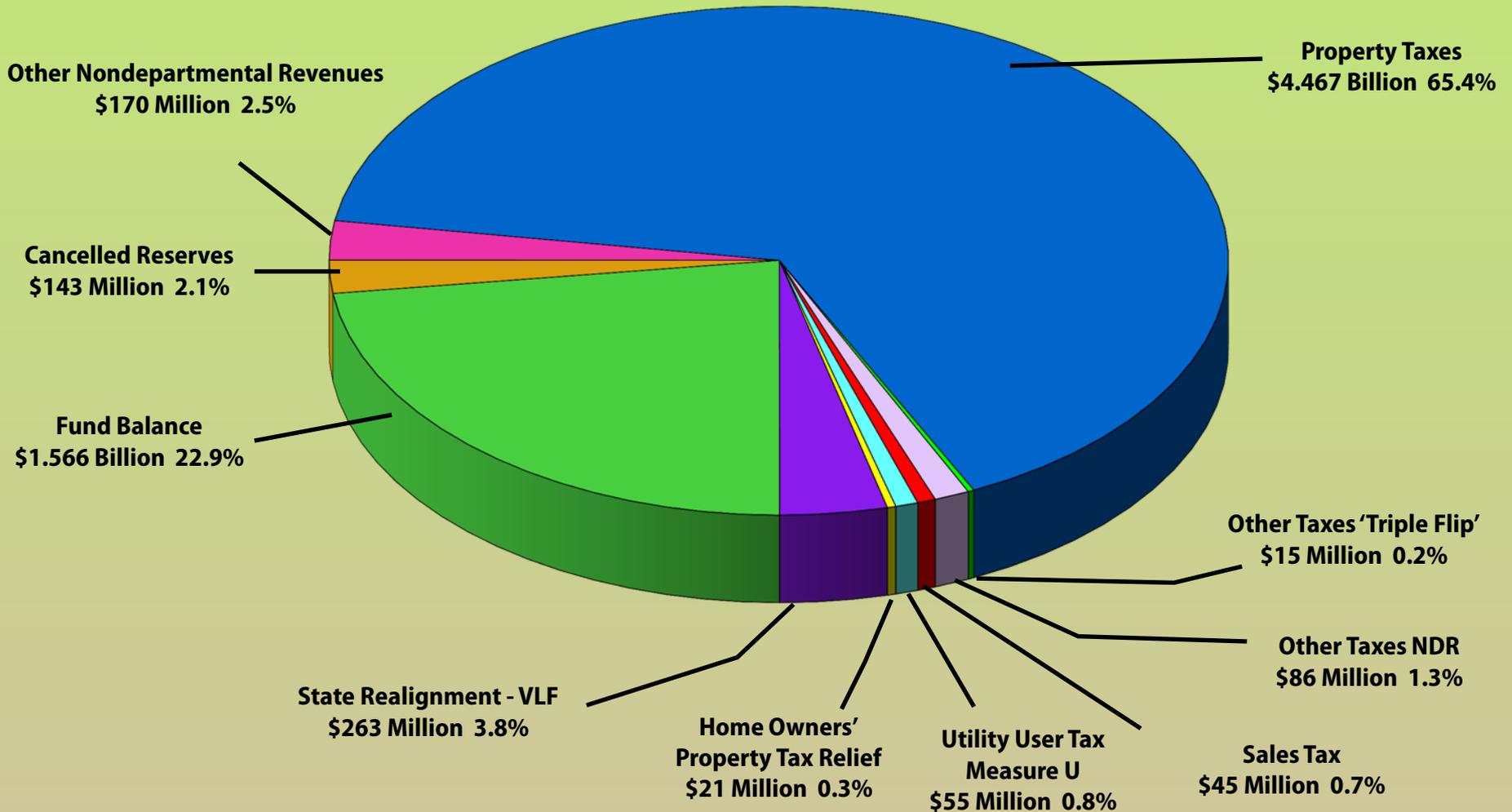

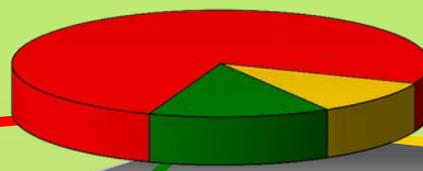
# Locally Generated Revenues
