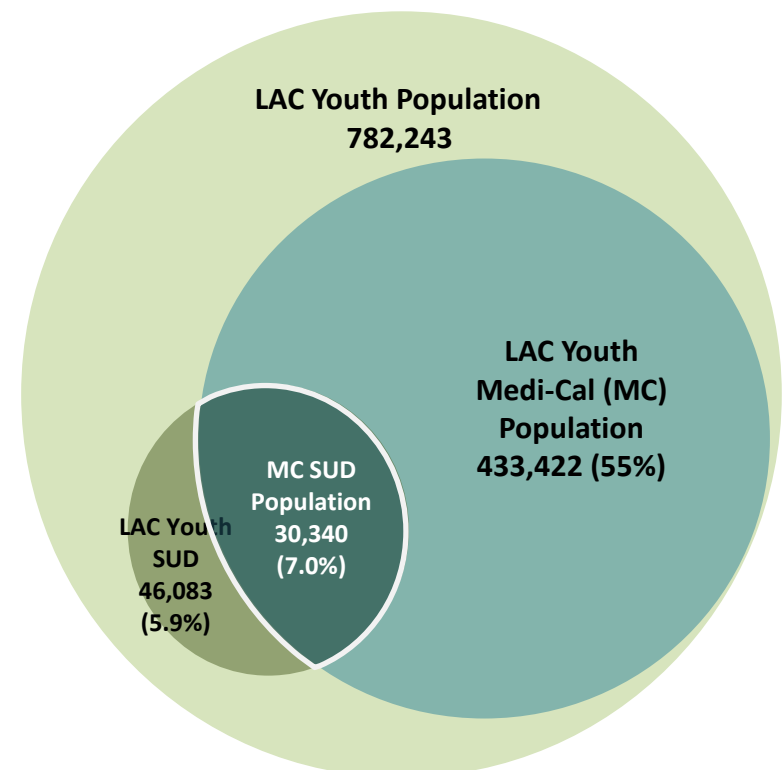
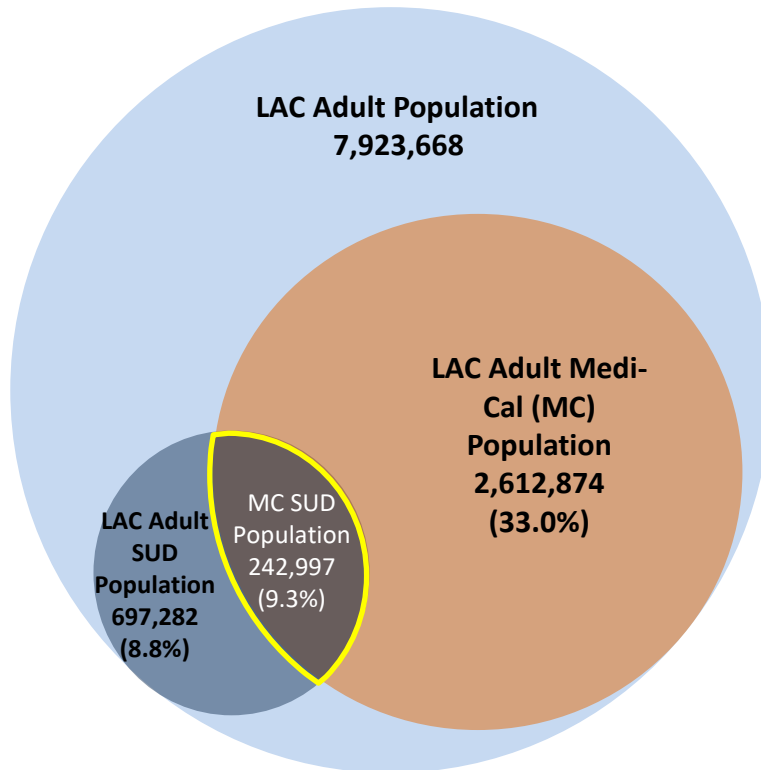

Publicly Funded Treatment Options

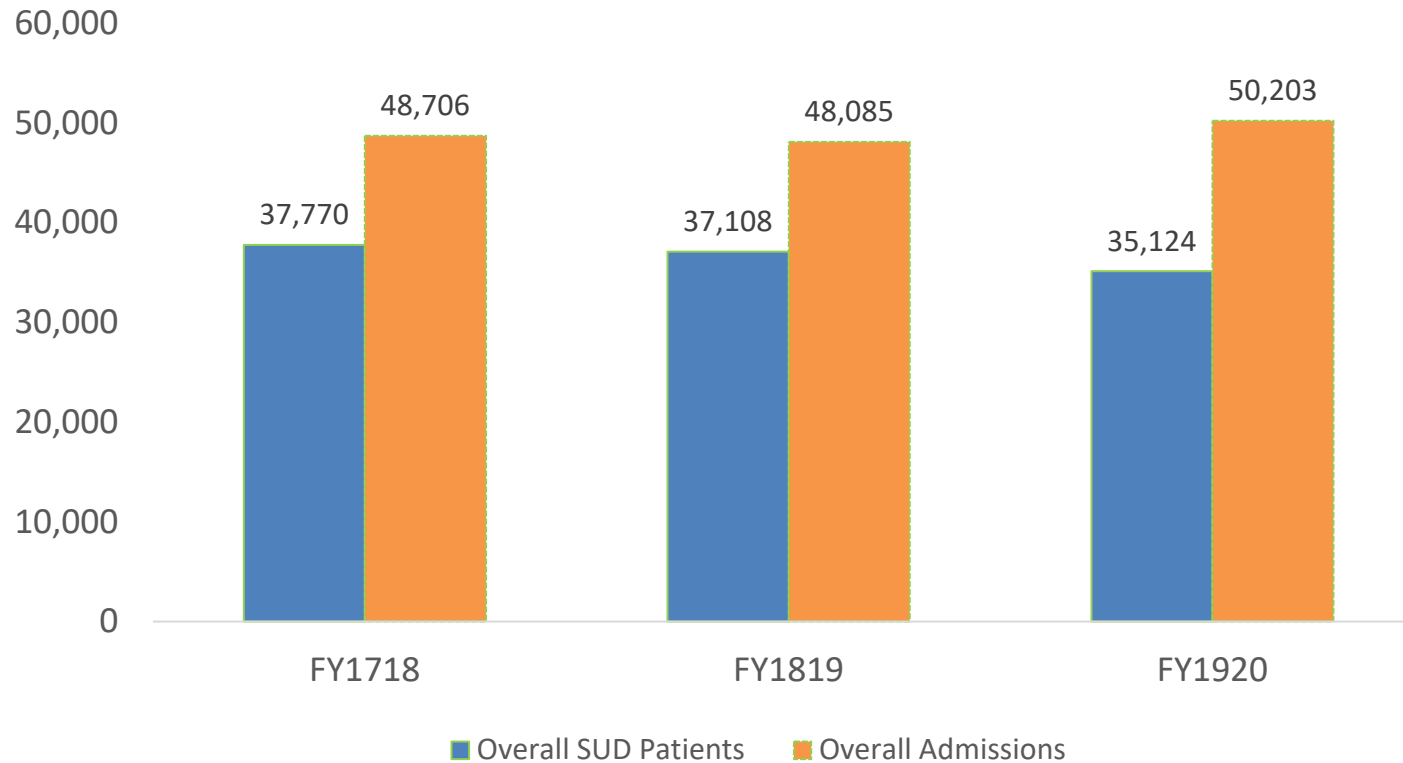
Level of Care	What Care Looks Like	Characteristics
Outpatient	Services provided in community setting, 2-3/ week	Minimal withdrawal risk, motivational strategies, able to maintain control over use with some support
Intensive Outpatient	Community setting 4-5/ week	Minimal withdrawal risk, requires more structured strategies, needs monitoring to prevent relapse
Residential	Short term onsite living and treatment	Minimal withdrawal risk, requires 24 hour structured environ to relearn life skills without substances
Opioid Treatment Program	Services provided in a community setting, 5-7 days a week for dosing and 1+ days of counseling services per month	Risk of withdrawal severe w/o treatment (Tx) Primarily for those with opioid use disorder, regular monitoring of dosing to prevent relapse.
Withdrawal Management (Detox)	Monitoring and/or management of withdrawal, limited to no counseling services	Risk of withdrawal from mild to severe. <u>Mild</u> – stay in Tx w/little to no medication <u>Severe</u> – unlikely to stay in Tx w/o medication, doing so can be life-threatening
Recovery Support Services	Support services after treatment is completed	Some to no risk of relapse, have some or limited support to maintain sobriety

SUD prevalence among Medi-Cal population ages 12+ in LAC=9%

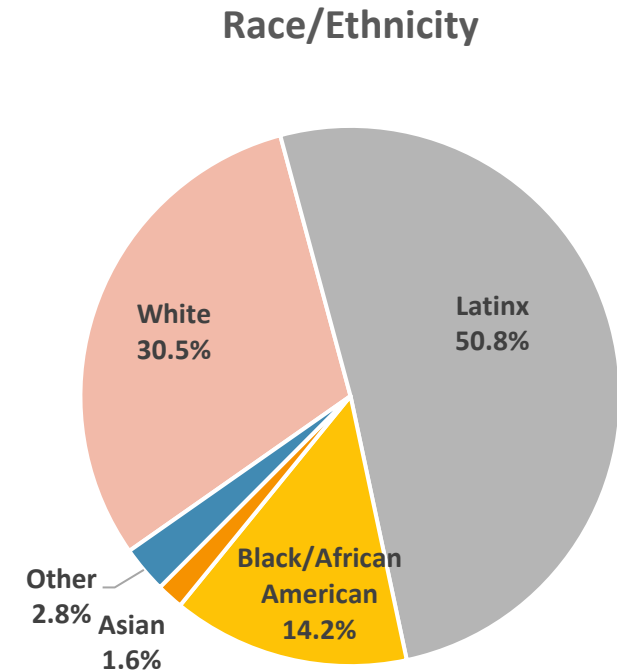
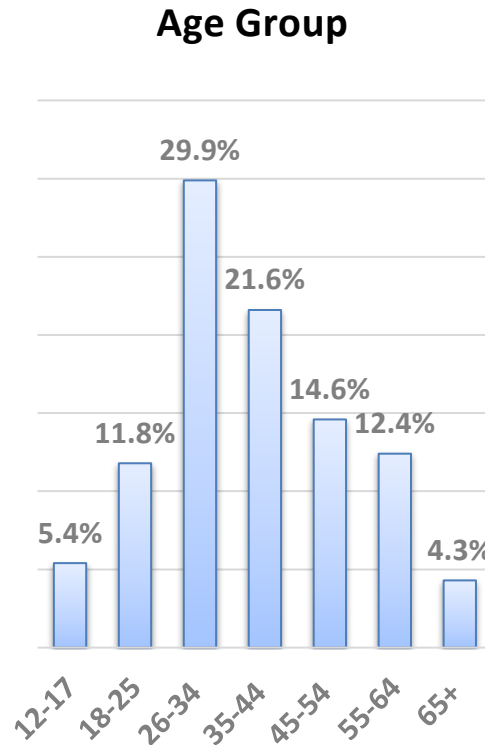
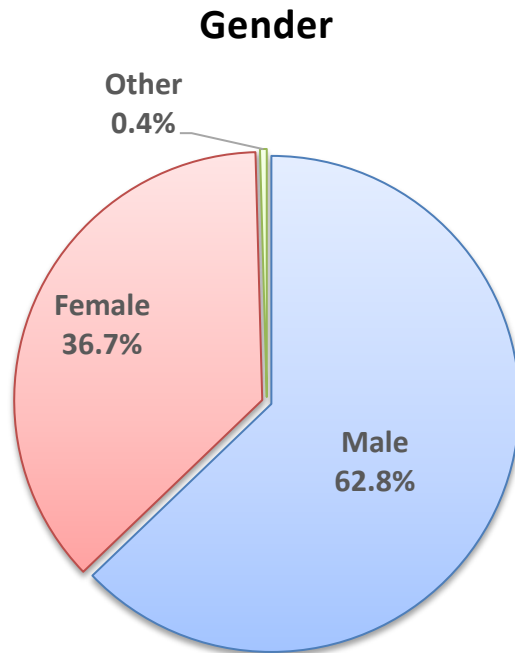
Total Number of Patients and Admissions, FY1718-FY1920

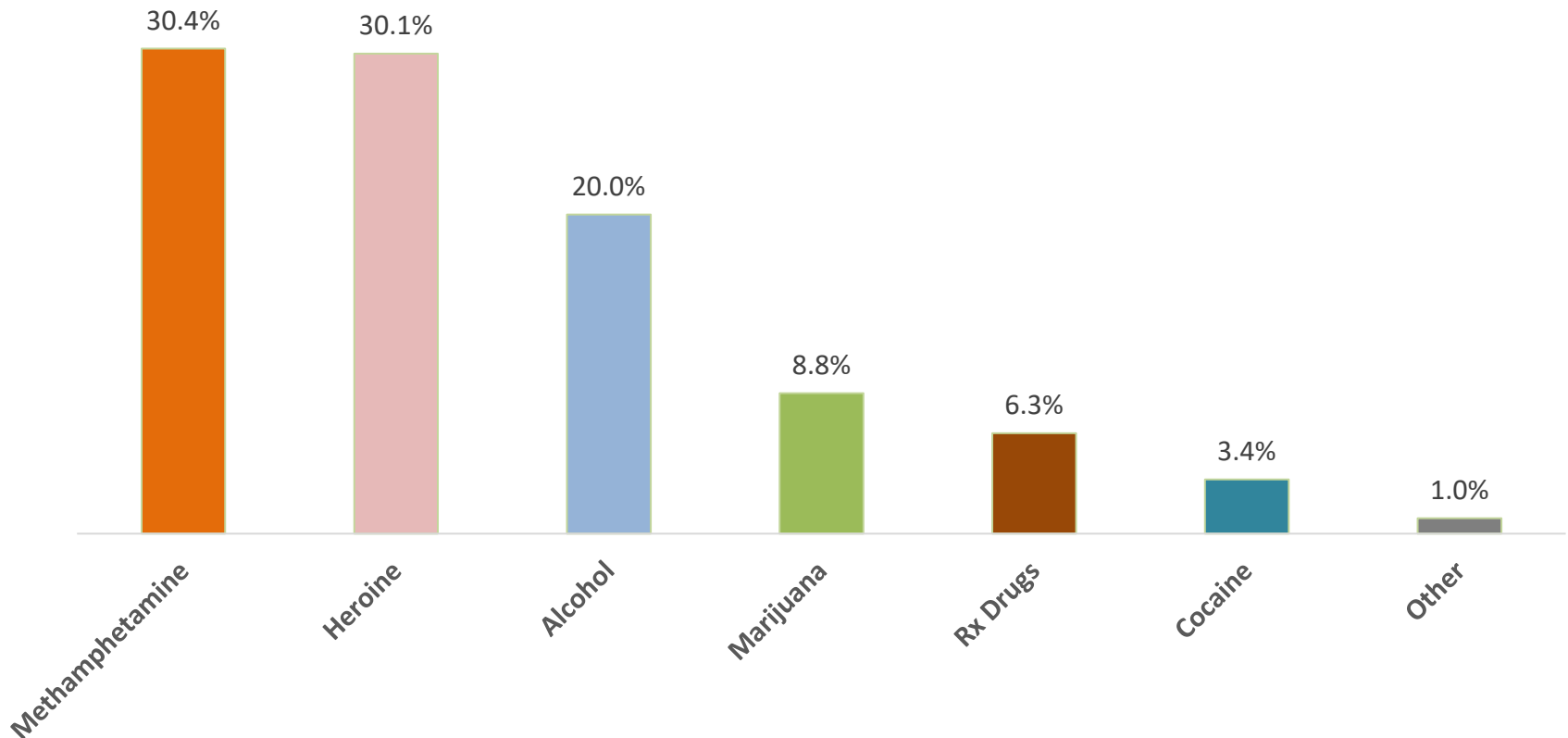
Demographics of SUD Patients Served in FY1920 (N=35,124 patients)

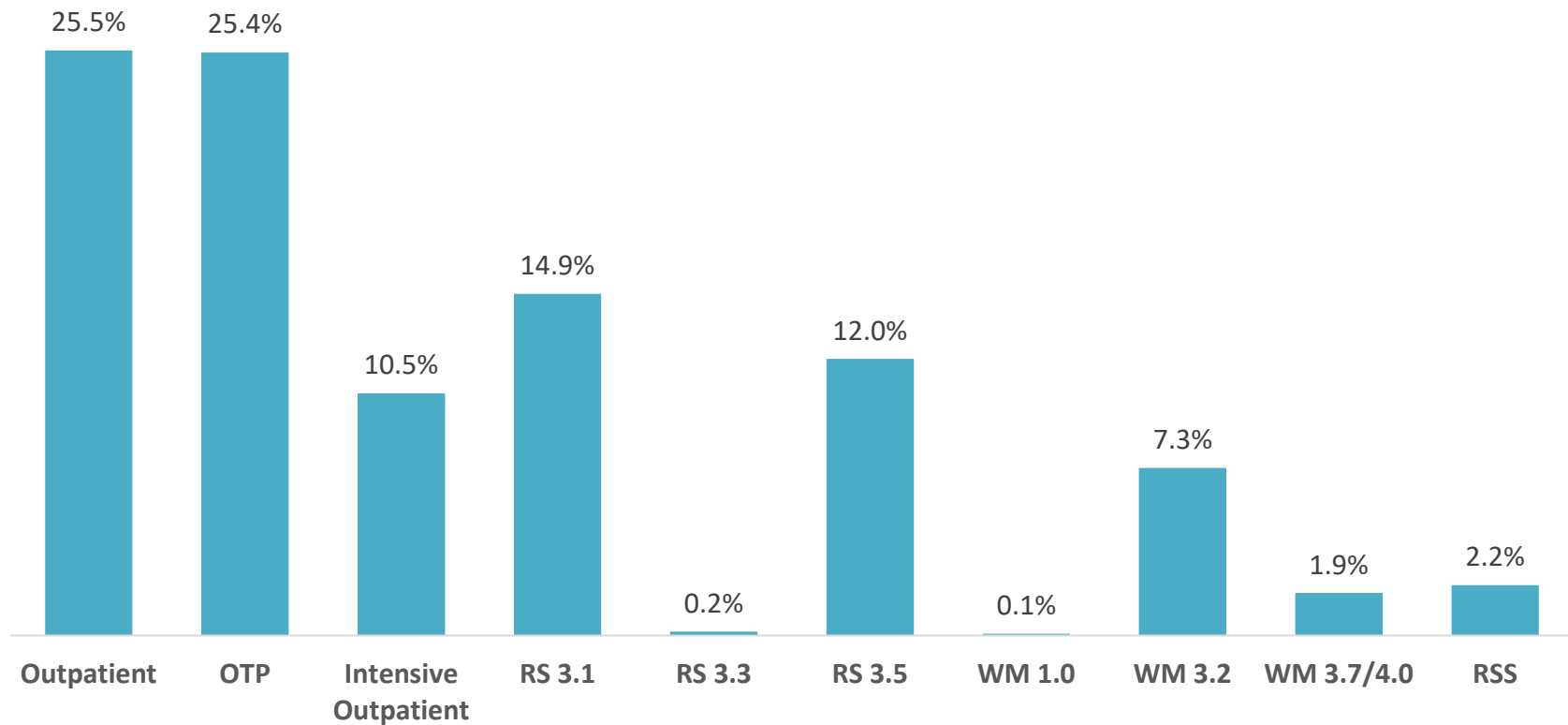
Primary Drug of Problem Reported at Admission, FY1920 (N=50,203 admissions)

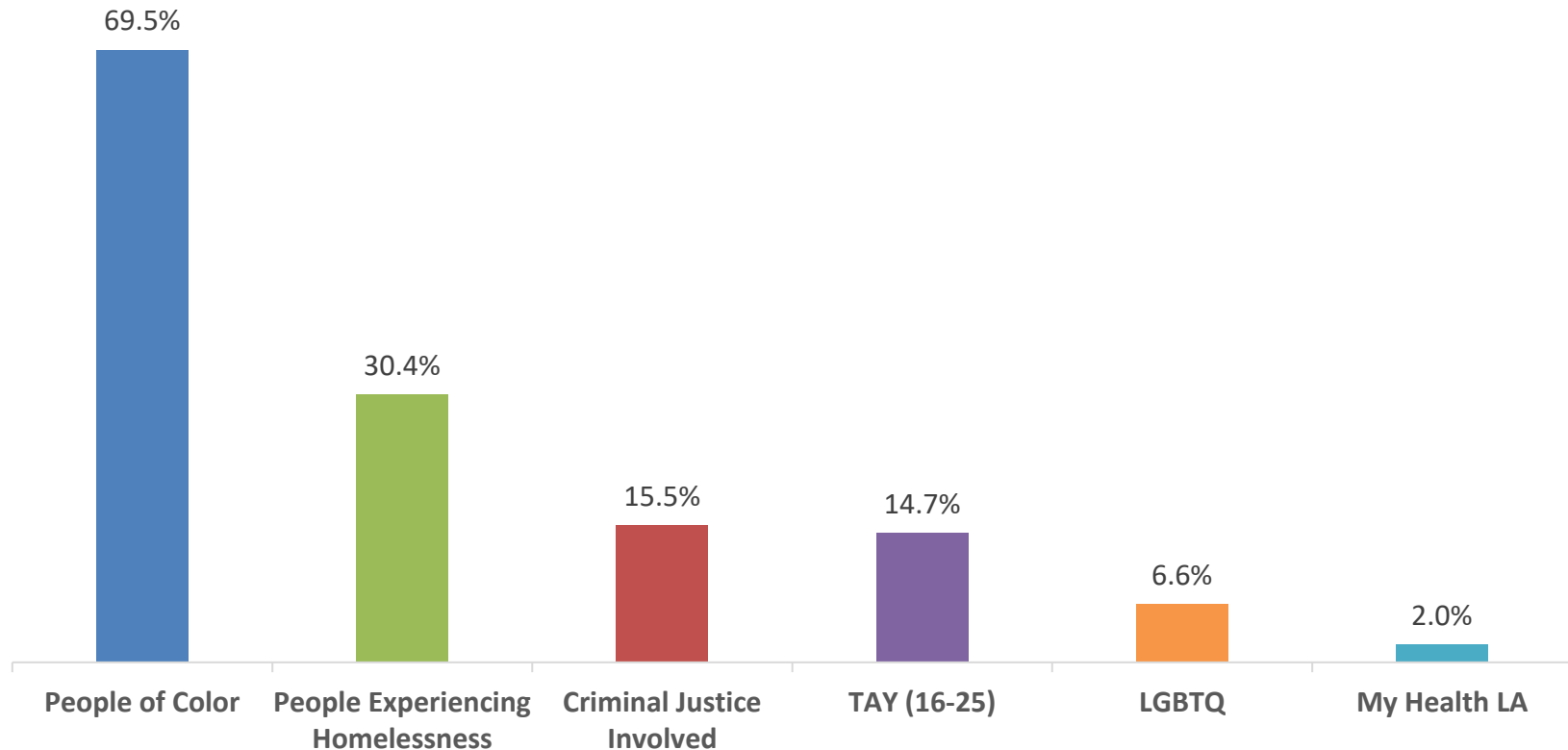

Type of Patients Served in FY1920 (35,124 patients)



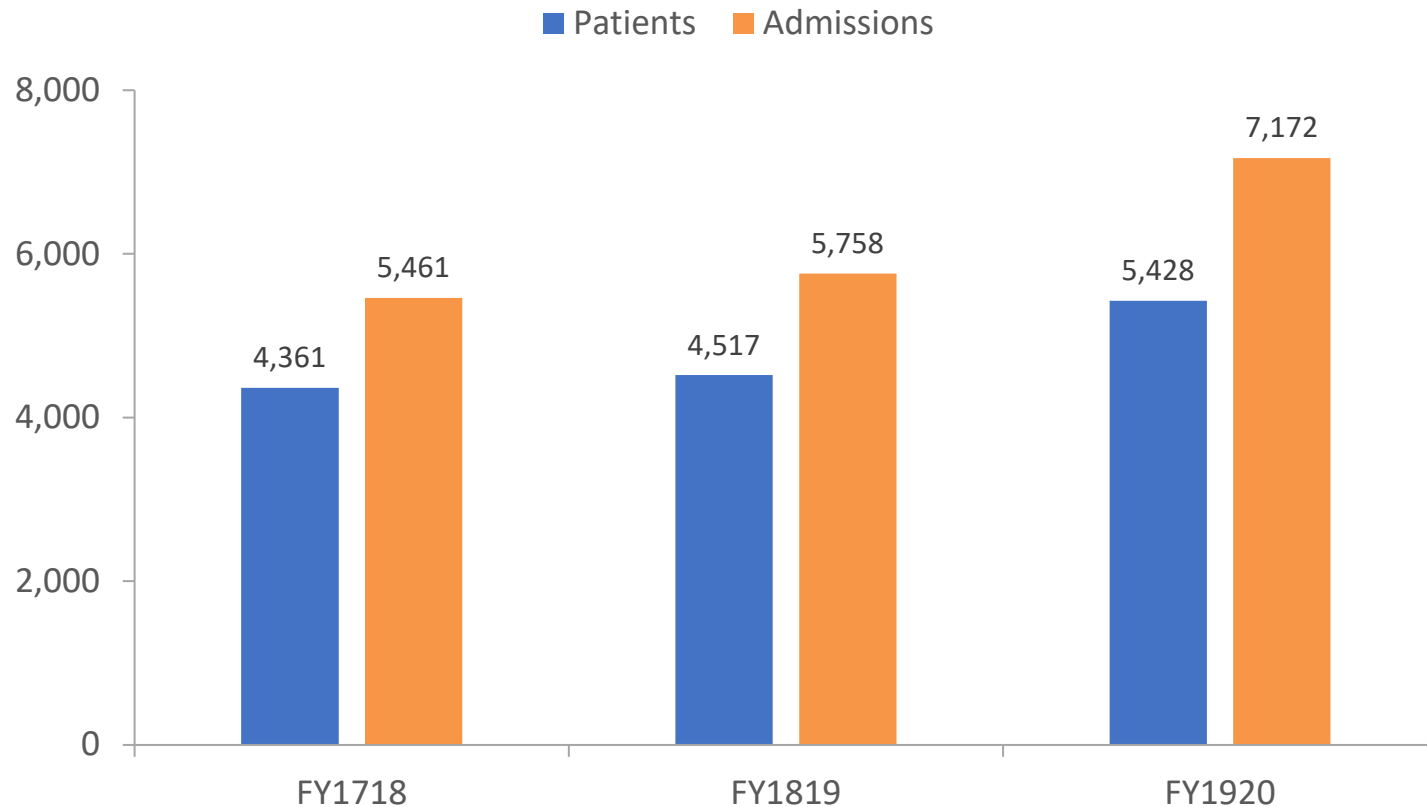

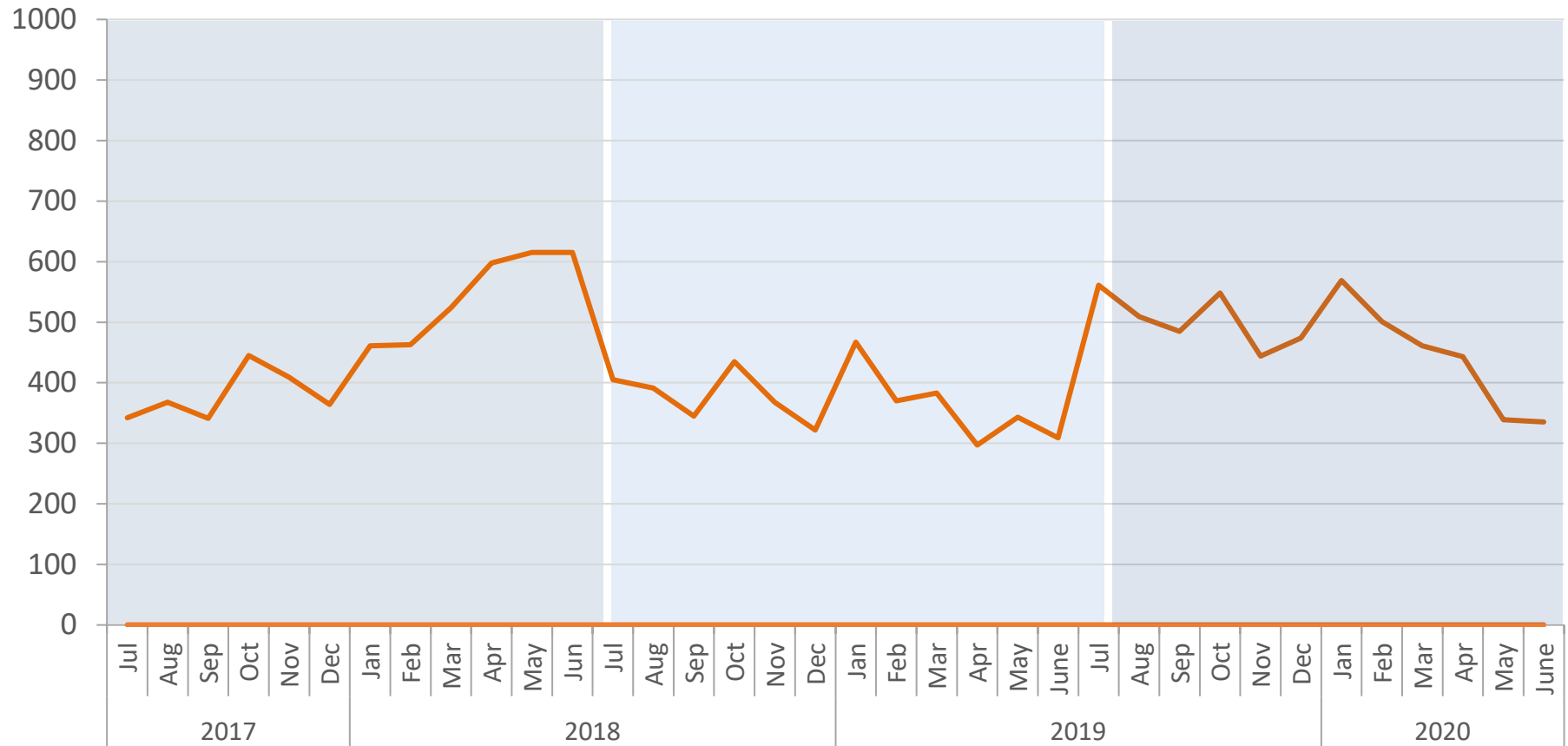
Total number of patients/admissions among criminal justice involved*, FY1718-FY1920

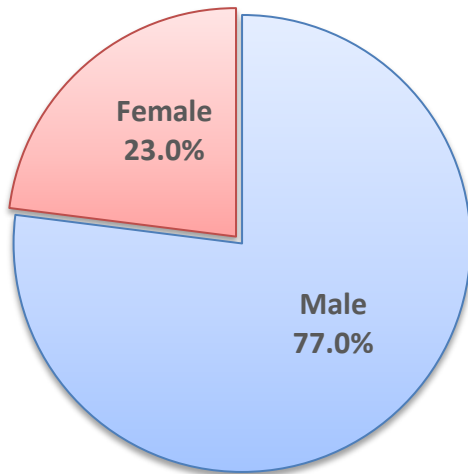
Number of new admissions by month among patients who are criminal justice involved, FY1718-FY1920



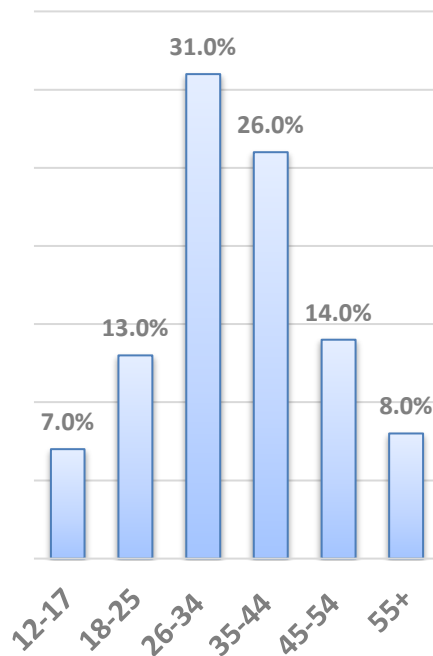

Demographics of Patients who are Criminal Justice Involved in FY1920 (N=5,428 patients)

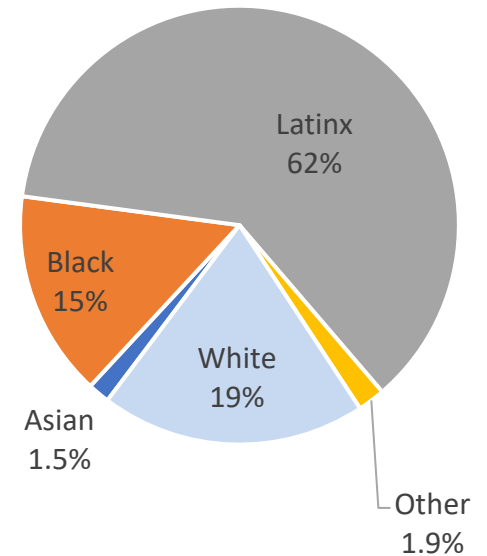

Age Group



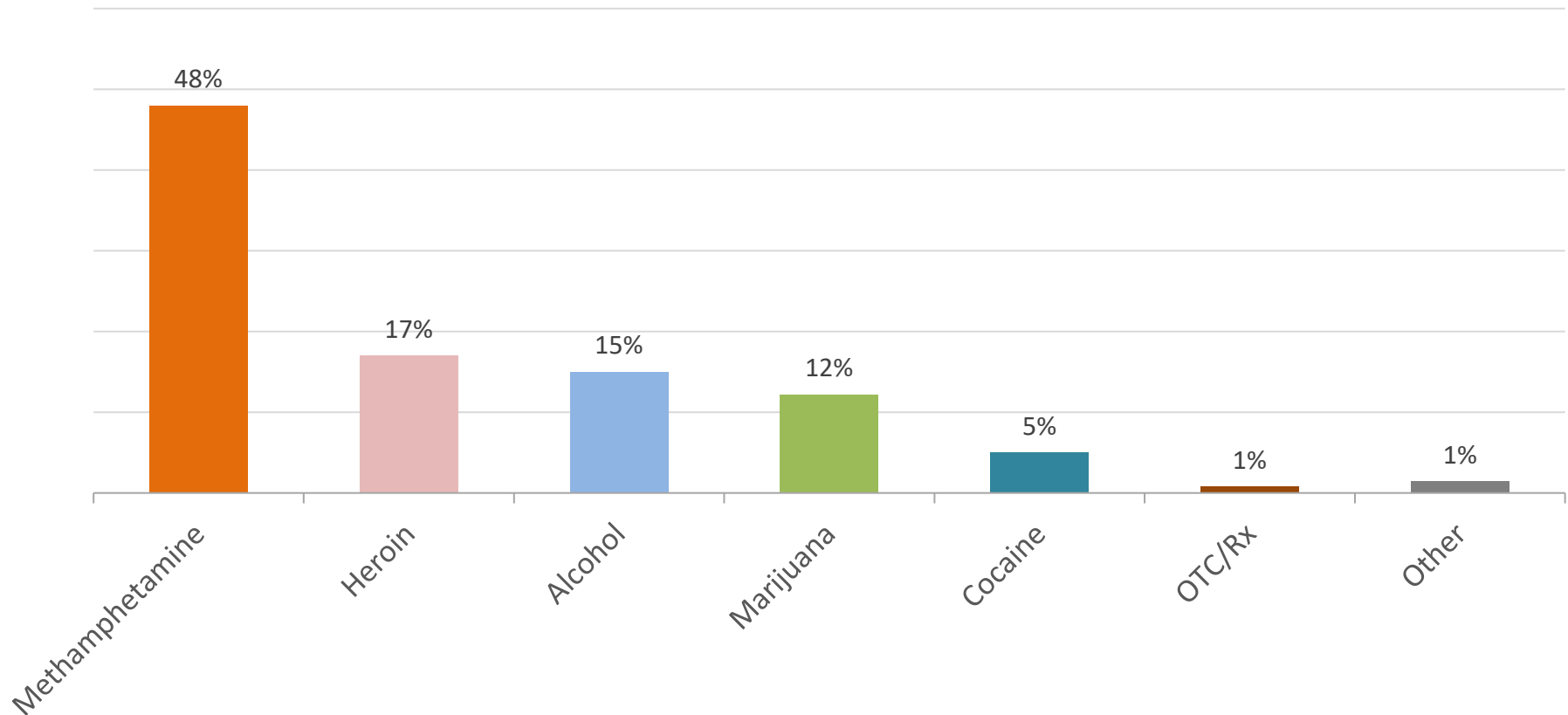

Primary Drug of Problem at Admission among Patients who are Criminal Justice Involved in FY1920 (N=7,172 admissions)

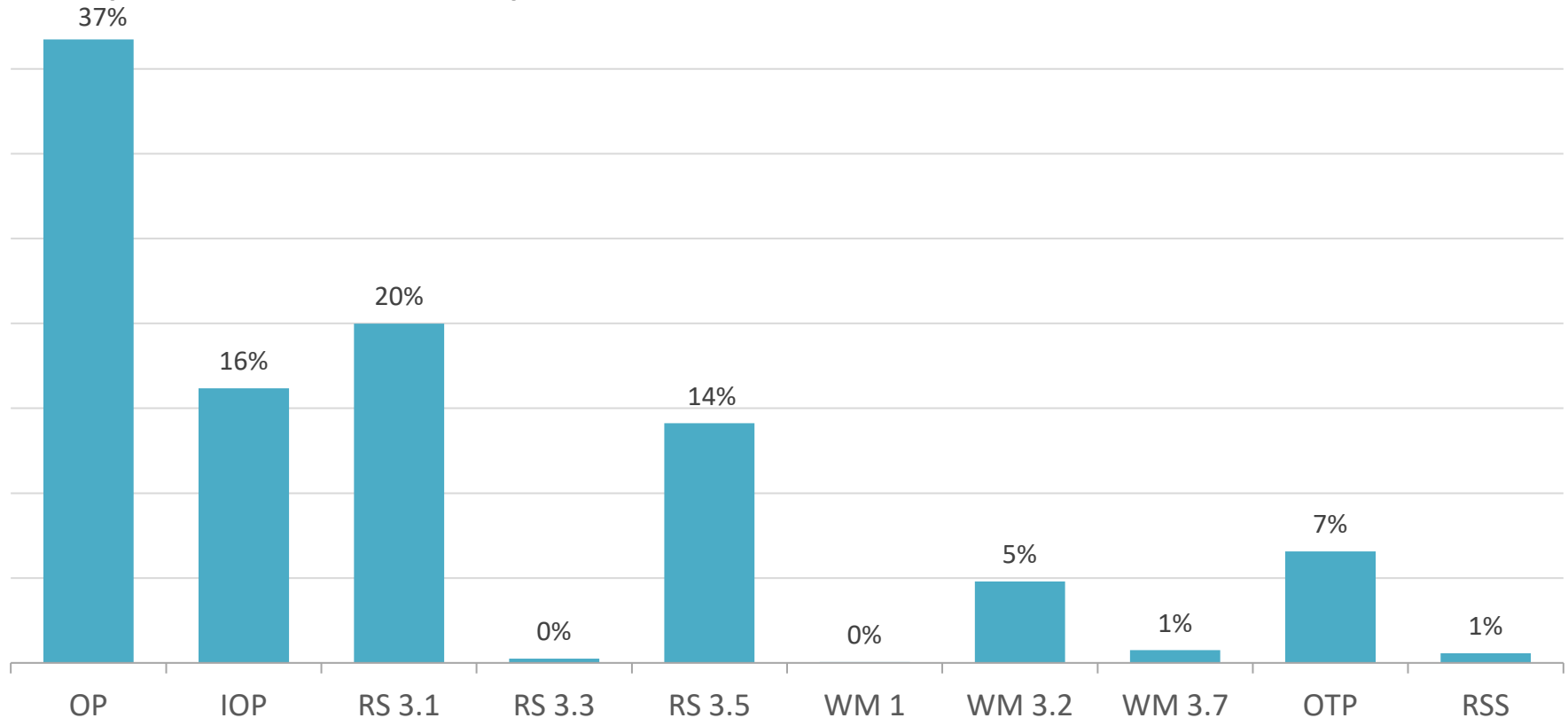

Level of Care Admitted among Patients who are Criminal Justice Involved in FY1920 (N=7,172 admissions)

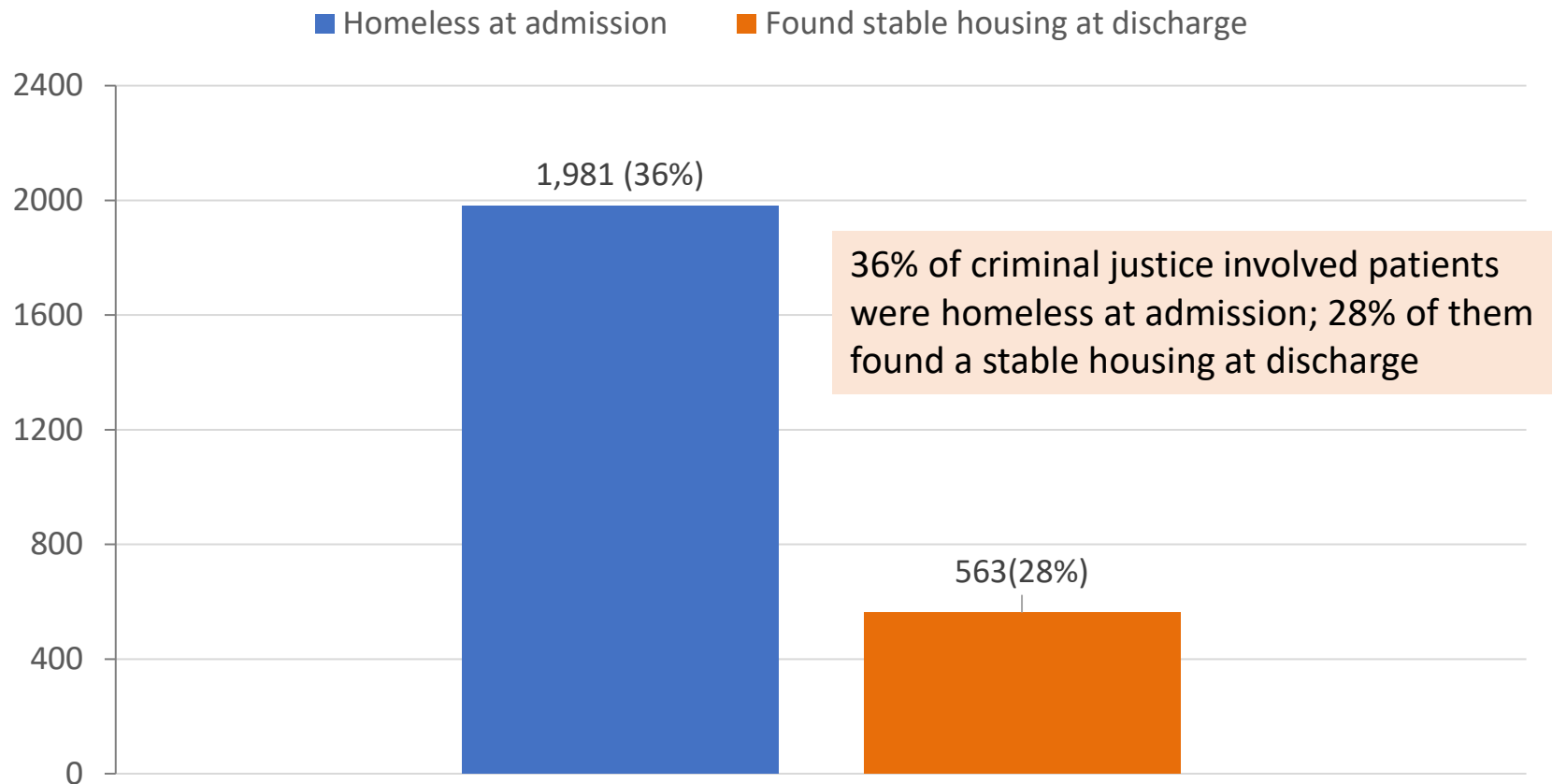

Number of patients who are homeless among criminal justice involved at admission who found stable housing at discharge in FY1920

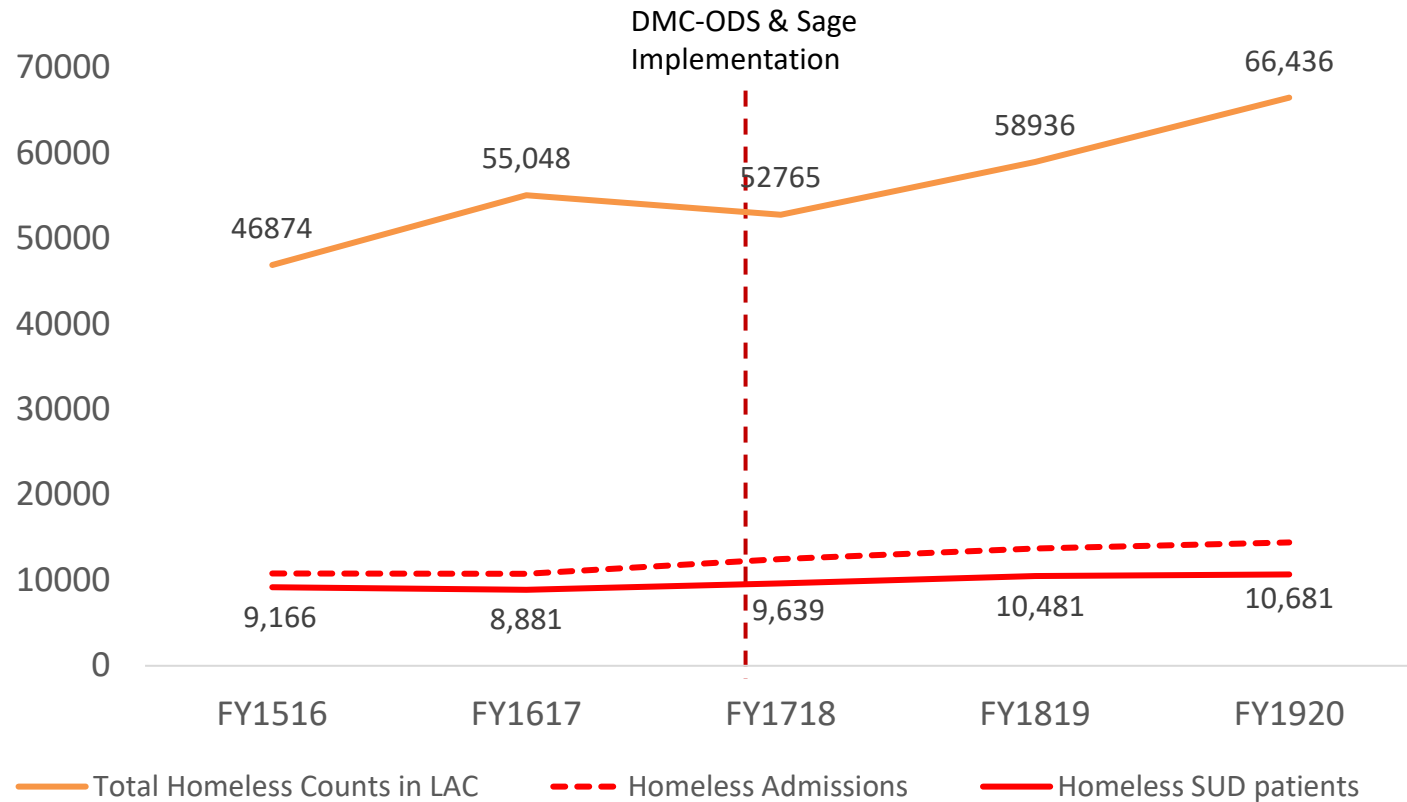

Patients who are Homeless (admissions) Served, FY1516-FY1920



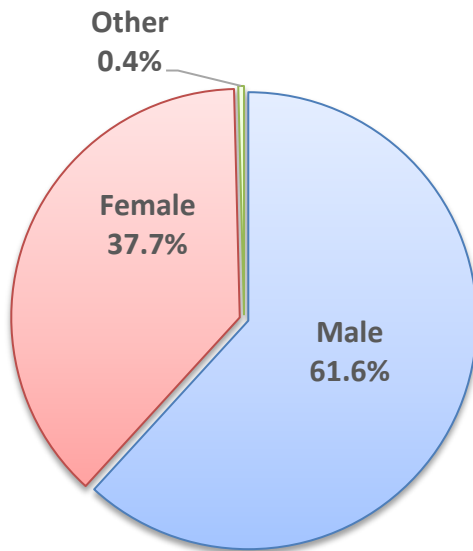

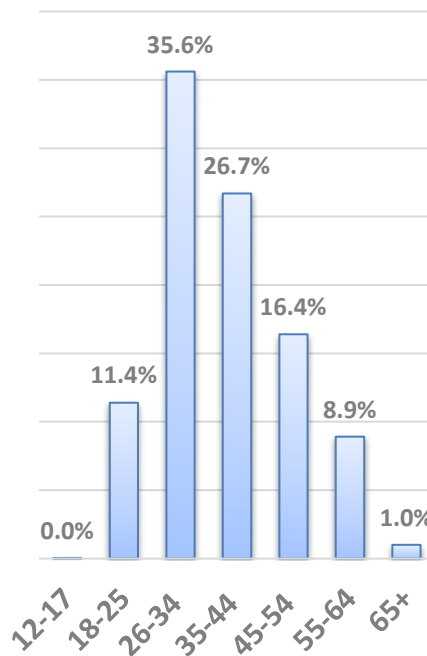

Demographics of Patients who are Homeless in FY1920 (N=10,681 patients)

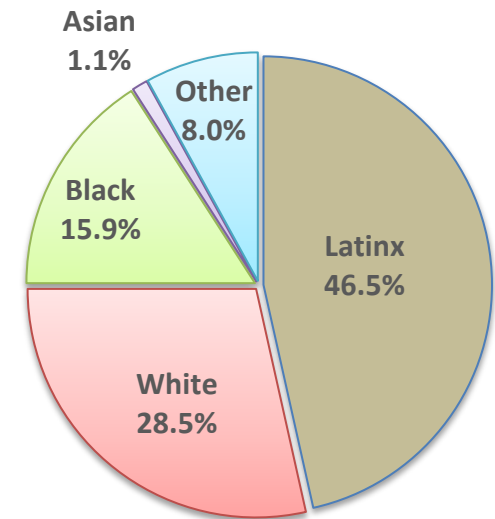
Gender



Age Group



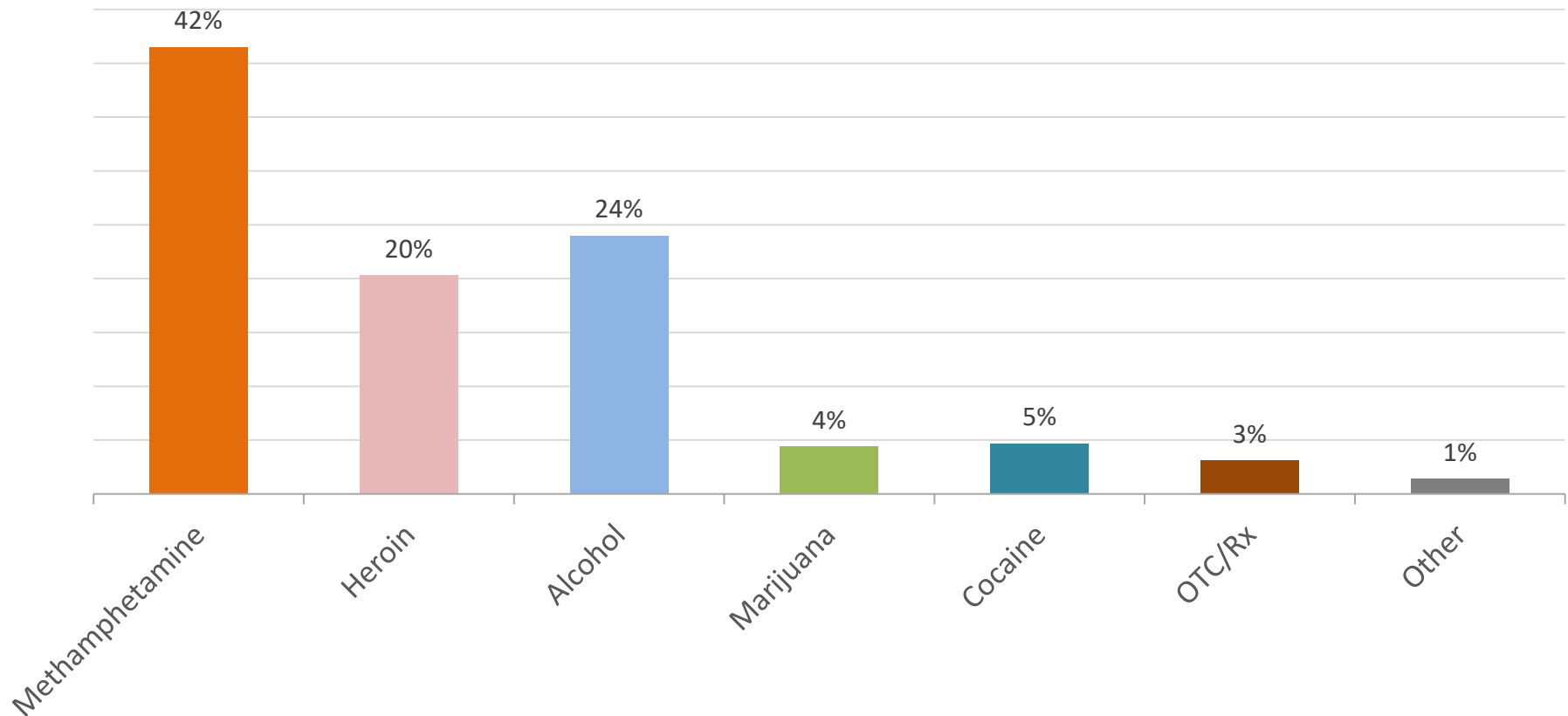

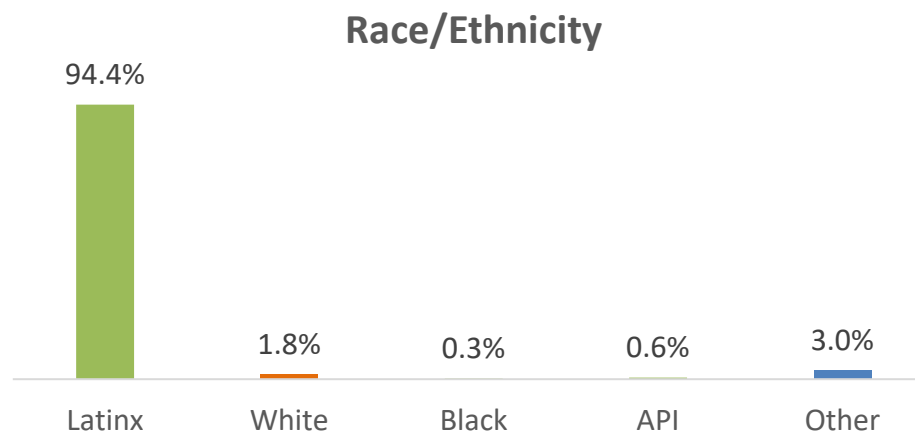
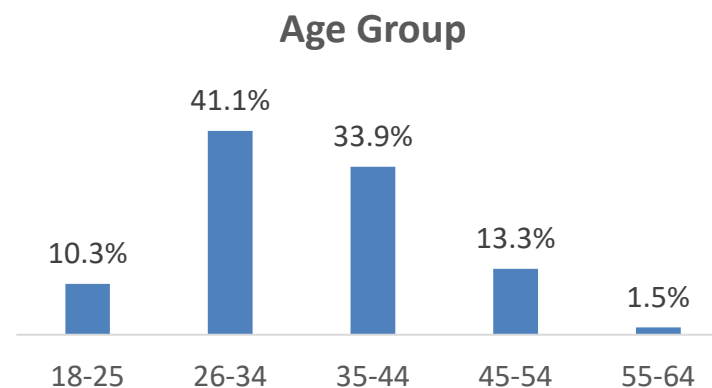
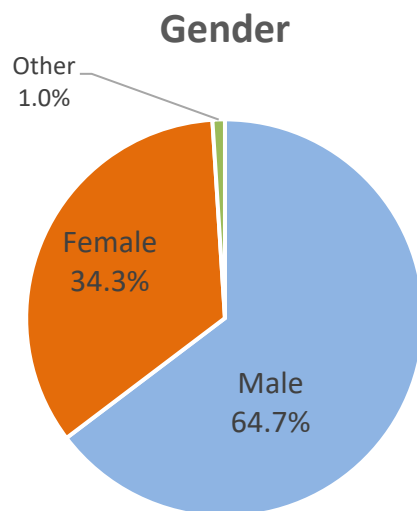

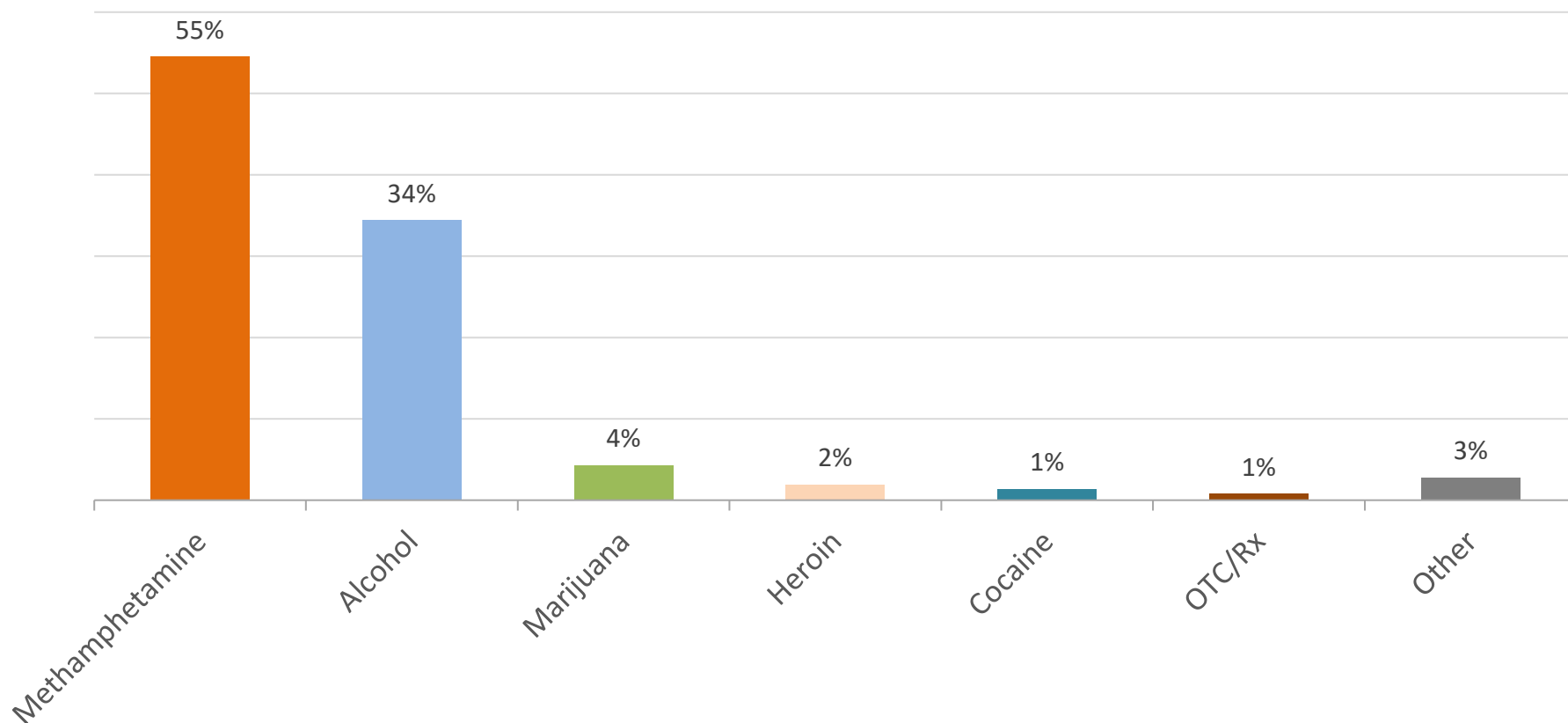
