## BASIC DATA REGARDING LOS ANGELES COUNTY EMPLOYEE ORGANIZATIONS

### I. County Labor at a Glance:

- There are 64 individual bargaining units and 2 negotiated fringe benefit agreements. Approximately 58 of the 64 bargaining units participate in one of the two negotiated fringe benefit agreements.
- The bargaining units are typically categorized in three broad groups, largely based on their participation in one of the fringe benefit agreements:
  - 1. The Coalition of County Unions (CCU) Collection of unions that negotiate collectively for fringe benefits, including health care benefits. One of those benefits currently is the "Choices" plan. 32 bargaining units receive benefits pursuant to this plan. There are also non-Coalition member unions that participate in the "Choices" plan.
  - 2. SEIU Local 721 A single union representing 26 bargaining units that largely share the first 42 articles of their MOUs (Common Language) and negotiate a single fringe benefit plan known as "Options."
  - 3. Independents 6 Unions that do not participate in either of the aforementioned fringe benefit agreements but negotiate terms and conditions through their bargaining representatives.
