A letter from Sarah Mahin, Director of the Department of Homeless Services and Housing

Dear Community Partners,

As we continue our transition to launch the County's first department on homelessness, I am reaching out with a few important announcements and reminders:

Service Provider Task Force

The County is currently <u>accepting applications</u> from service providers who currently hold housing and service contracts with Housing for Health and/or the Los Angeles Homeless Services Authority for the **Department of Homeless Services and Housing Service**Provider Task Force. The goal of the Task Force is to provide input into the creation of the new department. Measure A Labor Council Update

On September 9, 2025, the Board of Supervisors <u>appointed</u> eight individuals to serve on the Measure A Labor Council, equally representing organized labor and nonprofit social service provider leadership.
