Created in 1983 where the Mayor of Los Angeles and a group of business leaders met to discuss disaster preparedness. This group subsequently became a steering committee and formed the Business and Industry Council for Emergency Planning and Preparedness (BICEPP), established as a private-sector, self-help association funded by annual sponsorship donations. The organization later evolved into a non-profit corporation, led by an Executive Committee and a Board of Directors. The goal is to provide a forum for information exchange to enhance emergency preparedness and contingency planning within the business community.
